### 1) INTRODUCTION

This Expression of Interest (EoI) seeks response from eligible applicants, who are interested to associate with BEML for participation in Chennai Metro rolling stock tender as below,

Where ever, Chennai Metro tender is mentioned in this Eol document, the above tender / bid is referred to.

#### 2) About BEML Limited

- **2.1** BEML Limited (formerly Bharat Earth Movers Limited) was established in May 1964 as a Public Sector Undertaking for manufacture of Rail Coaches & Spare Parts and Mining Equipment at its Bangalore Complex. The Company has partially disinvested and presently Government of India owns 54 percent of total equity and rest 46 percent is held by Public, Financial Institutions, Foreign Institutional Investors, Banks and Employees. BEML Limited, plays a pivotal role and serves India's core sectors like Defence, Rail, Metro, Power, Mining and Infrastructure. The Company started with a modest turnover of Rs. 5 Cr during 1965 and thanks to its diverse business portfolio, the company has been able to achieve a turnover of more than Rs.4,000 Cr.
- 2.2 The Rail & Metro business of BEML Limited, was established to cater to the manufacturing needs of rolling stock in India. Starting 2002, BEML has successfully diversified into manufacturing of the state-of-the-art stainless steel Metro cars. BEML has been a pioneer in this area having supplied over 2000 metro cars till date. BEML's esteemed customers in the metro segment include Delhi Metro, Bangalore Metro, Jaipur Metro and Kolkata Metro. Further, BEML secured the driverless metro car contracts for the prestigious Mumbai Metro Line 2 & 7 project and Bangalore Metro Phase 2 project, which are presently under execution. Delhi Metro, the nation's most successful metro, is one of the major customers to BEML and presently, more than 60% of the rolling stock run by Delhi Metro is supplied from BEML factory.
- 2.3 In the Railway segment, since its inception, BEML has successfully rolled out varied range of products such as Rail Coaches, AC EMUs, DC EMUs, Stainless Steel EMUs, Rail Buses, 4 & 8-Wheeler OHE cars, Track Laying Equipment, Spoil Disposal Units, Utility Vehicle, BWTB Wagons, BFAT Wagons, BRSTN Wagons and BOMN Wagons. BEML Limited is the first rail Coach-manufacturing unit in India to get ISO 9001 accreditation. The division is accredited with ISO9001, ISO 14001 & BS OHSAS 18001 certifications. ### 3) <u>Scope of Cooperation</u>

- **3.1** Through this EoI, BEML intends to select eligible applicant(s) with whom, BEML can associate, submit and execute (if awarded) Chennai Metro tender.
- **3.2** This Eol is floated for Propulsion System and the envisaged Participation Model is formation of consortium between BEML and the identified applicant. Accordingly, applicants who are willing to form consortium for the project may only apply against this EOI.
- **3.3** Detailed Scope split will be discussed and agreed.
- **3.4** Duration of cooperation: Specific for Chennai Metro tender. During the course of association, both parties may mutually discuss and agree to extend the cooperation for further time as decided.

### 4) **INFORMATION TO APPLICANTS**

- **4.1** Reputed Propulsion suppliers may submit the application on their letter head along with the documents as prescribed in this EOI document.
- **4.2** For conversion of foreign currency into Indian Rupee, the exchange rate as on the last date of the respective financial year as per https://www.xe.com shall have to be adopted.
- **4.3** The NIT and Tender documents can be downloaded from the CPP PORTAL, https://eprocure.gov.in/eprocure/app. It is not obligatory upon BEML to publish addendums to this EoI to incorporate future tender modifications and the same are deemed to be automatically incorporated within this EoI.
- **4.4** By virtue of submitting application against this EoI, the applicant confirms the following:
  - A. The Applicant has downloaded and studied the tender documents including all addendum(s) / corrigendum(s) / clarifications that were published until the date of its Eol response submission.
  - B. The applicant is aware of the actual site conditions of project.
  - C. The applicant shall diligently study all the future addendums / corrigendum / clarifications and ensure continued compliance to EoI and tender conditions.
  - D. In case due to a future tender modification as above, there is an impact on the applicant's EoI response, the Applicant has to bring the same to the notice of BEML within 04 days of such tender modification date.

- **4.8** The details submitted by the applicants shall be complete. However, BEML may seek clarifications / additional information as considered necessary. Such clarifications / additional information must be provided within 03 days of BEML request or early as may be required by BEML.
